**Waiver and Release of Liability:**

In consideration of my child being allowed to participate in any way in HPP Rinx Inc. d/b/a/ The Rinx, and HPP Summer Camp Inc., athletic/ sports events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. There is a possible risk of injury from activities involved in this program and while rules and personal discipline may reduce the risk, the risk of injury does exist.
2. I knowingly and fully assume any and all such risks which are inherent in the activities in which I or my child are engaged, both known and unknown, for myself and my child, even if arising out of the negligence of the releasees and am allowing my child to participate in all activities voluntarily and am willfully undertaking and assuming all such risks.
3. I willingly agree to have my child comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence, I will remove my child from participation and bring such to the attention of the nearest camp official immediately; and
4. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless the Town of Islip, HPP Rinx Inc., and HPP Summer Camp, their officers, officials, agents and / or employees, and other participants, ("releasees"), with respect to any and all injury, disability, death or loss or damage to person or property whether arising from the negligence of the releasees or otherwise.

I/we have read this release of liability and fully understand its terms. I/we further understand that there are certain risks inherent in the activities engaged in and I/we assume said risks. I/we have given up substantial rights by signing this release and signing it voluntarily and free from coercion. Should any portion of this agreement be determined unlawful, all other portions remain in full force and effect.

**For the general welfare of all participants, the Camp reserves the unrestricted right to dismiss any participant whose conduct or influence, in the opinion of the directors, is contrary to the best interest of the campers and the camp.**

**Hidden Pond Day Camp is not responsible for any "Lost" personal property that participants may take to camp.**

**Permission to provide Emergency Care:**

In the event I cannot be reached in an emergency, I hereby give permission to the physician selected by the camp director to secure and administer all necessary treatment, including hospitalization and emergency diagnostic treatment for my child enrolled at Hidden Pond Day Camp (HPP Summer Camp, Inc.) and Sports Clinics. I also give permission to release any records necessary for insurance purposes; and to provide or arrange necessary emergency related transportation for me/ or my child. This completed form may be photocopied for a trip out of camp.

This contract constitutes a full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and signed by both parties.
