By enrolling my child and signing the bottom of this document, I agree to and understand all that follows:

Hidden Pond Day Camp, is accredited by the American Camp Association, is licensed by the New York State Department of Health, and is inspected yearly. Copies of the inspection are kept on file in the County Health Department Office.

This contract is not valid unless signed by enrolled camper's parent or guardian (the "signor") and accepted by the Camp Director. The signor agrees to pay the tuition as per the published schedule for the enrollment period. In the event this contract is executed by one parent, the signor acknowledges that he/she is also acting as an agent of the other parent with authority to enroll the child at camp and to execute this contract on his or her behalf.

Tuition includes: 1 t-shirt, camp bag, daily lunch, daily snack, and use of all athletic equipment.

A non-refundable Deposit of \$400 per child is required at the time of sign up.

\$300 is applied to the tuition and \$100 is a one-time registration fee per camper.

For your convenience, when enrolling, please select one plan that best meets your needs.

Anyone signing up after 1/31/27 is expected to submit a 20% payment of each child's enrollment fee, plus a \$400 non-refundable deposit.

Anyone signing up after the final payment date April 23, 2027 is expected to pay in full at the time of signing up.

There will be a \$75.00 fee for changing enrollment weeks after June 1, 2027. This does not apply to extensions.

The Balance of tuition is due April 23, 2027.

Hidden Pond reserves the right to cancel the child's registration if full payment is not received by **April 23, 2027.**

P.M. Extended:

If a child is not picked up during dismissal, he/she will be placed in our PM Extended Program. Payment for the PM Extended program is due in advance or at the time such services are rendered. The fee for this service is \$20 per day.

(Please pay as you need it – money paid in advance and not used, is not refundable.)

By enrolling my child, I hereby grant permission:

1. To photograph and video my child during Camp Activities and to allow Hidden Pond Day Camp to utilize such photography and or video for promotional purposes. This includes, but is not limited to our Website, our Social Media Page, and advertising.
2. To participate in any camp sponsored trips during their enrollment period.
3. To participate in all programs that are arranged by the camp and supervised by Hidden Pond Day Camp Staff.
4. To ice skate and swim.

I am enrolling my child with the understanding that there is inherent and potential risk of injury while participating in camp activities.

Waiver and Release of Liability:

In consideration of my child being allowed to participate in any way in HPP Rinx Inc. d/b/a/ The Rinx, and HPP Summer Camp Inc., athletic/ sports events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. There is a possible risk of injury from activities involved in this program and while particular rules and personal discipline may reduce the risk, the risk of injury does exist.
2. I knowingly and fully assume any and all such risks which are inherent in the activities in which I or my child are engaged, both known and unknown, for myself and my child, even if arising out of the negligence of the releasees and am participating or allowing my child to participate in all activities voluntarily and am willfully undertaking and assuming all such risks.
3. I willingly agree to have my child comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove my child from participation and bring such to the attention of the nearest camp official immediately.
4. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless the Town of Islip, HPP Rinx Inc., and HPP Summer Camp, their officers, officials, agents and / or employees, and other participants, ("releasees"), with respect to any and all injury, disability, death or loss or damage to person or property whether arising from the negligence of the releasees or otherwise.
5. I/we have read this release of liability and fully understand its terms. I/we further understand that there are certain risks inherent in the activities engaged in at camp and I/we assume said risks. I/we have given up substantial rights by signing this release and sign it voluntarily and free from coercion. Should any portion of this agreement be determined unlawful, all other portions shall remain in full force and effect.

I also agree that my child/children's CampDoc profile will be completed before the start of the camp season.

For the general welfare of all campers, the Camp reserves the unrestricted right to dismiss any camper whose conduct or influence, in the opinion of the Camp Director, is contrary to the best interest and safety of the campers and the camp. (See and sign "Behavior Affidavit" in CampDoc)

Hidden Pond Day camp is not responsible for any "Lost" or "Stolen" personal property that campers may bring to camp.

Permission to provide Emergency Care:

In the event I cannot be reached in an emergency, I hereby give permission to the physician selected by the camp director to secure and administer all necessary treatment, including hospitalization and emergency diagnostic treatment for my child enrolled at Hidden Pond Day Camp (HPP Summer Camp, Inc.). I also give permission to release any records necessary for insurance purposes; and to provide or arrange necessary emergency related transportation for me or my child. This completed form may be photocopied for a trip out of camp.

This contract constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and **signed by both parties.**

Hidden Pond Day Camp at The Rinx Cancellation/Refund Policy

1. All Payments (less a non-refundable deposit of \$400) shall be refundable until April 23, 2027.
2. If a child, prior to the commencement of his/her enrollment period, is unable to attend camp because of an appropriately documented illness or injury, all monies will be refunded less the \$400 non-refundable deposit.
3. No refund will be made for late arrivals, early departures, or dismissal for cause. Tuition and fees are agreed to be the reasonable amount as and for liquidated damages.
4. If tuition is not paid as per the schedule of payments set forth on this application, early enrollment credits and or discounts will not adhere, and enrollment may be cancelled, and no refund made.
5. If you would like a payment plan, please call the office.
6. There will be no refunds or make-up days for non-consecutive missed days of camp due to illness, family matters, homesickness, or injury. If a camper is **absent consecutively for three days or more, due to medical reasons only**, a refund, or credit towards an additional week or next years' enrollment will be made for each day missed, provided a physician's note is submitted appropriately evidencing medical reasons for the absences.
7. Due to camper security **no makeup days are permitted**.
8. All "Refund Requests" must be made promptly and in writing.
9. **There will be a \$75.00 fee for changing enrollment weeks after June 1, 2027. This does not apply to extensions.**

10. Enrollment Extensions

If you wish to add weeks to your enrollment, at a later date, the cost will be calculated based on the enrollment rates at the time of your enrollment. **If you enrolled during the summer sale, your extensions will be calculated based on returning camper rates.**
